Committee reports:

Airport: Mr. Wilt reported that there is a change in how the FFA does grant applications. One thing they changed when you used to get the grants the engineers would do the forecast come up with a number and get the grant from the FFA then you would go out to bid, now you go out to bid and get a number then try and get the grant. Some of the grants take two years to get and they will give you that number and that is all you will get. So you either accept or deny the grant. I just wanted everyone to be aware of the process. So if the bids come in and you take the low bid you go to the FFA they give you that number and you don't get that grant for two years they expect you to hold the bidder to it, they do give them in the bid process nine month holding time.

Snowmobiles: Mr. Knapp reported that the tracks for the big groomer are in. Need to order some bolts and I would also like to get prices on power poles for the new bridge. They will be fifty footers.

Mr. Wilt reported that the town got the voucher from Parks and Recreation; we ended up getting \$41,790.00 for the snow mobile grooming.

New Business: Mr. Wilt reported that there are a couple things coming up, The Adirondack Water Fest on July 31st. 10-4pm

Mr. Wilt reported that the town may have to hire another assistant swim instructor having a little conflict on the days with the current assistant instructor.

Highway Superintendent: would like one of the Town Board members to call an executive session about a personnel matter.

Old Business: B Baker reported on the joint committee with the Piseco School, they have met twice, currently have taken the square footage of the offices in the Piseco Community hall and the school available rooms. The committee is unanimously in favor of working toward the solution if possible and feasible to move the town offices up to the vacant spaces in the school building. At this point we are putting out a couple of different scenarios of where the rooms would fit and where they would best be served. We are getting advice from the school attorney, what has to remain school and security wise for the children as we deal with the Justice Court. The next meeting is scheduled for July 29th where we would like to put together a blue print of where we think the offices will go and whether they will fit, and then we will make a recommendation to the Town Board and the Piseco School Board. Then to an architect to formally do drawings to code, there will need to be a couple security doors.

Mr. Wilt reported that in a couple weeks two engineers will be coming to look at the Highway complex, asked if Highway Superintendent Parslow could be there. They want to get an idea if what is there and what needs to be done.

Mr. Wilt reported that Dam engineers are set to start late September to evaluate the spill way.

B Baker: said that there is a question on two of the bills, Charles John's bill, voucher #413 is without any particular receipt attached, and the other is a fuel bill voucher #372 for one of the vehicles shows about two thousand miles in two days it must be an error in the odometer reading.

Highway Superintendent Parslow: said there needs to be new signs for the Arrowhead Road. The one way road sign is not enough, people are not going both ways and there is going to be an accident. Wilt said the town will buy two new signs, a DO NOT ENTER and ONE WAY.

Fred Knapp asked why the town did not use metal eye beams instead of light poles for the snow mobile bridge. Wilt said he will talk to Tracy Eldredge to see if the county had any old bridge beams.

Sarah Rudes asked if the town could put the previous minutes on the town web page before the next meeting and the Agenda for the next meeting.

Jamie Parslow Regional Supervisor for the boat washing stations gave a presentation on the pilot program, she feels prevention and education about the invasive species is very important to get out to the public.

Andrew Knapp wanted to thank the town for the transition to Mel Lascola the new Zoning Officer. Would like to know what the next steps for the Piseco Lake Lodge, and if the Town Board are all in favor. The Board recommended that Mr. Knapp return to the Planning board to apply for a Special use permit. Sarah Rudes member of the Planning board also spoke to Mr. Knapp recommending that he go to the Planning for and apply for a Special use permit.
