The changes are as follows:

Improvements: DA5112.2 from \$160,000 to \$132,928.

Misc. Brush & Weeds: personal services DA5140.1 from \$9,000 to 9,000.

Snow Removal (Town Highways): personal services DA5142.1 from \$61,050 to \$55,000. Snow Removal (ST& Co Highways): personal services DA5148.1 from \$81,400 to \$71,000

Hospital and Medical Insurance DA9060.8 from \$152,250 to 145,000.

Estimated Revenues

State Aid: consolidated highway DA3501 from \$40,000 to \$132,928.

Mr. Wilt: stated the General budget with the unexpended balance minus the \$40,000 in capital projects we are within a thousand of where we are supposed to be. The Highway is somewhere close, will have the numbers before the next meeting.

Mr. Baker: will have some numbers for the next meeting for health insurance costs.

Mr. Wilt: asked if everyone received the email he sent on the court case Casey vs. Town of Arietta?

Public Comment: Sarah Rudes had questions on the highway budget line Snow Removal contractual expenses DA5148.4. Sarah also wanted to know how many ZBA members have had the mandated training. Mr. Wilt said he did not know off the top of his head. This is an issue that needs to be discussed.

Mesonet wants to put a weather station at the Airport. They will send a contract, Wilt said he will send it to the Lawyers. There will possibly be a 30' tower but will have to be approved by the APA.
