Airport: Mr. Wilt reported that things at the airport are quite.

Chamber of Commerce & Street Lights: Mrs. Grier had nothing to report.

Youth & Website: Mrs. Wilt reported that there were a quite a few kids signing up for ski lessons at Oak Mountain this past weekend.

Snowmobile Trails & Town Buildings: Mr. Knapp reported that the bridge at Piseco Lake Lodge. He said that there are five more that have to be replaced on the Oxbow trail. He said that DEC will supply all of the materials. Mr. Wilt said that the snowmobile grant came in. He said it was estimated at \$38,000 and it was actually just under \$43,000. Mr. Wilt also reported that the Town of Arietta has snowmobile trails in the Towns of Indian Lake, Long Lake and Inlet. These towns would like to be reimbursed for grooming these trails as Arietta gets paid for them under the grant. He said it won't be a lot but it is right to reimburse them so he will have something drawn up for the next meeting that will be similar to the agreement with Lake Pleasant Riders.

Highway Superintendent: Not present.

Mr. Wilt asked Brian Rudes to report on the Piseco Lake Association for the last year. He said that the complete report is on their website at www. pisecolakeassociation.org. He encouraged everyone to come to a meeting at the Piseco School on December 9th, 2015 at 1pm for a meeting of the Adirondack Lakes Alliance Region D trying to deal with the use of salt on roads and the impact it has on lakes.

Mr. Wilt reported that the fire siren at the Piseco Airport needs to be replaced. Mr. Baker said it was World War surplus. He said that the new one is more directional and should reach farther down Piseco Lake. Mr. Wilt has received approval to install it back at the airport from the FAA as long as it isn't installed any higher than the antenna's that are there now. The woman's axillary will be funding the purchase of the siren.

Mr. Wilt reported that they met with the architect about what needs to be done to the Piseco School to move the Town offices there. They have the preliminary drawings back but not the final ones. He said hopefully they will have them at the school board meeting on this Thursday. If they go ahead it will take a minimum of ninety days to get a permit. So if they go ahead the work won't begin until March at the earliest.

Mr. Wilt reported that he finished the new employee daily report documents. The only problem is that he put the snowmobile trail numbers on them and DEC changed all the trail numbers so he will have to redo them. He plans on having them done for the December 21st, 2015 end of year meeting.

Mr. Wilt reported that there will be a representative from AFLAC here on Thursday December 10th, 2015 at 1pm at the Community Hall for any employee who would like to meet with them.
