Subject: Lease Agreement between Town of Arietta and the Piseco Common School District

WHEREAS: the Town Board of the Town of Arietta has been presented with the Lease Agreement from the Board of Trustees of the Piseco Common School District for use of a portion of its property, to be used by the Town of Arietta for its Town offices (see attachment), and

WHEREAS: the initial term of this lease shall be for five (5) years, beginning June 1, 2016 and terminating May 31, 2021. At which time if the Town of Arietta desires to renew the Lease for an additional five (5) year term must notify the District at least sixty days (60) before expiration of the lease agreement, and

WHEREAS: for the duration of the term identified in Paragraph "3", rent shall be \$1.00, payable from the Tenant to landlord upon execution of this Agreement, and

WHEREAS: the Town of Arietta shall be obligated to pay twenty (20) percent of the Landlord's electric and heating costs, based on the heating and electric bills received by the Landlord as outlined in the attached, and

WHEREAS: the Town Board has reviewed the attached Lease Agreement and all the terms and conditions, and all promises made by the parties are in this lease and there are no others. This lease may be changed only by an agreement in writing signed by and delivered to each party, and

THEREFORE LET IT BE RESOLVED: that the Town of Arietta, Town Board will accept and approve the attached Lease Agreement between the Town of Arietta and the Board of Trustees of the Piseco Common School District and authorize the Town of Arietta Supervisor to execute the lease.

Subject: Undertaking for the Benefit of the NYSDOT in Connection with Work Affecting State Highways

WHEREAS: the Town Board, of the Town of Arietta has been presented with an Agreement from the New York State Department of Transportation for Town of Arietta to conduct activities and operations upon highways and/or within the right-of-way controlled by the State of New York (see attached), and

WHEREAS: the Town of Arietta access and operation upon state right-of-way is conditioned upon compliance with Highway Law Sections 52, 103, 203 and/or 234, and

WHEREAS: in relation to all operations and/or actions undertaken within state right-of-way, Town of Arietta herby agrees to the terms and conditions as outlined in the attached, and

WHEREAS: the undertaking shall be applicable to all permitted activities and operations undertaken after the date of execution and work initiated while this Undertaken is in effect, and may be revoked by the Town or rejected by NYSDOT upon thirty (30) days written notice, but will continue to apply to all permitted future activities/operations that were permitted by virtue of this Undertaking, unless terminated for the purpose of future activities/operations, this Undertaking shall have a term of twenty (20) years and shall be kept on file to facilitate the issuance of future permits to which it will apply, and

THEREFORE LET IT BE RESOLVED: that the Town of Arietta, Town Board will accept and approve the attached Agreement between the Town of Arietta and New York State Department of Transportation and authorize the Town of Arietta Supervisor to execute the Agreement.

M Knapp: reported that the Snowmobile grant seems to be approved.

Supervisor Wilt reported that Mr. Baker sent out a garbage letter to all the Town Board members and will wait for a later date to discuss the issue.

S Rudes asked then if the town was changing the policy, that the town of arietta is no longer providing the dumpster like they used to provide to the commercial operations?

Supervisor Wilt: reported a new lawn mower replacement was purchased for the use at the cemetery and Community hall.

Bryan Rudes gave an update on the Aquatic Invasive Species grant.

Supervisor Wilt: reported the phone system is half done at the school and would like to move all the offices except the main offices making sure all the phone systems are working. Wilt said he is planning on having the July board meeting at the school.

Supervisor Wilt: reported the letter to the residents at the airport went to the attorney then to the FAA and the FAA is still not happy with the language in it, such as the number of people that have a right of ways to the airport and are entitled to it. Wilt believes the letter will be done some this week.

Mary Schlansker would like to advocate for the upkeep of the open spaces in the town, such as the Airport, Ambulance building, Fire house, Community building, the school. She said there are a few very dedicated people that have been working in some of the gardens around town. Motion was offered by: B Baker

S Rudes asked if a letter was to go out to land owners she would like a copy.

Supervisor Wilt: reported that there are still a lot of black bags in the garbage, it is now required to have clear trash bags.

S Rudes asked if the Town vehicles have town seals on them. Wilt said they are all labeled.
