Mr. Knapp reported that Chaps for the employees who use chainsaws on the snowmobile trails will cost \$99 per pair and helmets will be \$52 each. He will need three of each.

He also informed the board that he needed to purchase 60 boards to work on snowmobile bridges. He also informed the board that they will be moving the snowmobile bridge behind Piseco Lake Lodge over 15' to where it was originally which will allow them to use 6"X6"s instead of having to get telephone poles.

Mr. Wilt reported he sent the board information on the Mesonet weather station at the airport. He said they are supposed to have it done by December 1st, 2016. Anyone who would like to know the amount of snow or weather in Piseco they can go online and get it. Mr. Wilt will try to get it linked to the Arietta Town website. Mr. Wilt reported he has a video conference this Wednesday November 9th, 2016 at 10:00am in Saratoga with the FAA on the Through the Fence issue at the Piseco Airport.

New Business:

Mr. Wilt reported he wants to push getting the employee evaluation forms completed. Mrs. Wilt and Mr. Baker will do them.

Old Business:

Mr. Wilt reported the DEC grants for the boat wash stations have been executed by the State so the town can now submit the two vouchers to the State for payment.

Mr. Wilt feels the Planning Board and Zoning Board of Appeals pay needs to be done by the end of the year. The board already decided to give each member a \$500 stipend at the end of each calendar year in which they serve on a board.

Mr. Wilt reported that the creation of capital reserve projects needs to be done as well.

Mrs. Rudes asked if the Board of Assessment Review received any pay. Mr. Wilt said no they never have.

Mrs. Rudes reported that Mr. Boni should have the sign at the Community Hall done sometime this week. He is also working on the signage for the school building offices.

Mr. Wilt reported that the heating system at the Piseco School building should be done this Thursday the 10th. He said that there will be training on the heating system Thursday morning.

Mr. Baker reported that there will be a meeting with Town employees on November 10th, 2016 at 9:30am with the Town's insurance broker to learn about the new health insurance plan the Town will have starting January 1st, 2017. (Excellus BCBS Simply Blue Plus Platinum 4)

Mr. Baker reported that Mr. Knapp and he met with the entire highway department and the two Supervisors office staff about the future employee agreement to start January 1st, 2017. He reported they talked about wages, compensation time, vacation time, the pay schedule steps and other issues. Mr. Baker feels that some of them can be addressed by updating the employee handbook. He will send the board a complete overview of what was discussed so they can review it before the next Town Board meeting in December.
