Mrs. Rudes stated that the agreement associated with this resolution that in section #4 it says "The Chamber shall report to the Town on or before August 31st of each year, a statement of services provided in the past year and an estimated budget for services to be provided in the coming year, inclusive of anticipated revenues, specifying administrative and related costs for sponsored events and promotional services". Mrs. Rudes told Donna Benkovich of The Adirondacks Speculator Region Chamber of Commerce that she would like to make these payments made contingent on the Town receiving the report. The first two payments would be made January and April will be paid, but the report will be due before the next payment will be made. Donna was ok with this and said she will present the report as required by the agreement. Mrs. Rudes said she feels Donna's word is good and Mrs. Rudes then made the motion to pass the resolution.

Mr. Wilt asked Donna Benkovich of The Adirondacks Speculator Region Chamber of Commerce to talk about the chamber. She said Jim Tazares and herself were here to let the board know that they are running the chamber now and they are open to ideas from the board.

Mrs. Wilt reported that she has been working on the employee evaluation forms. She has taken the one Hamilton County uses and has eliminated the sections she feels aren't needed.

Mr. Knapp reported he has been looking into different towns and how they do their roof projects. He said that many of the things in the plans for the Community Hall roof project can be eliminated. He said the plywood, ice & water shield by just re-nailing the strips and he showed he the board a new produce that is a water barrier and insulation all in one. He said you roll it out on the roof boards & tape it and the roofing can go right on top of it. Mr. Wilt said that the engineers will be here next week to finish the school project and he asked Mr. Knapp and Mr. LaScola to meet with the to go over these change possibilities.

Mr. Wilt reported he has talked with Senator Schumer's office about the RTFF at the Piseco Airport. He said they are trying to fix the issue, but if they are able to make the changes it won't be until sometime next year. He said that means that the Town will not be doing any projects at the airport next year. Mr. Wilt reported that he talked to Myron the surveyor who is supposed to do the Piseco Lake Dam project. Myron has had health issues and he is trying to get here sometime next week. Mr. Wilt told him he can't even see the dam now. Mr. Wilt feels we need to look for someone else to do the surveying if Myron doesn't show up next week. Mrs. Rudes suggested maybe contacting Dennis Phillips legal firm to see if he knows anyone else who can do this kind of issue as dams are special and are different than most projects.

Mr. Wilt reported he would like to send the letter to the people who have dumpsters on their property for garbage pickup telling them they will be responsible for all repairs and upkeep on them from now on. The board would like to have the dumpster at Point road brought closer to Route 8. Mrs. Wilt will contact Lee Billington about moving it. Mr. Wilt will send a copy of the letter to the board members for their review before he sends it out. He asked them to respond ASAP with any corrections the feel are needed. Mr. Baker said he could move the dumpster on his property if that is needed as well. Mrs. Rudes said she doesn't understand what problem the board is solving with the letter so she is dissenting, but she is in the minority.

Mr. Wilt reported that Zoning Board of Appeals and Planning Board will be paid at the end of each year with a single pay check.

Mr. Wilt reported that the new sign at the Piseco School to show the Town offices looks good. Mrs. Rudes said that Mr. Boni said he will repaint the posts in the spring when the weather gets better.

Mrs. Rudes asked if the Town was still going to sand driveways during ice emergencies. The board said they would like to continue to do it.
