Committee reports:

Snowmobile Trails & Town Buildings: Mr. Wilt reported the new snowmobiles should be delivered Thursday morning from Village Rentals. Mr. Knapp reported he and Jim Abrams went and looked at the trail reroute on Sheriff Lake to see where trees need to be cut. They need a bridge that will be about 14 feet long. The bridge they put in last year needs some work, but it will have to wait until the water goes down. He ordered 60 planks from Tracy's Sawmill. He also said that the Spy Lake trail bridge needs to have put approaches on it or Mr. Inoue may shut the trail down as he can't get across the bridge with his four wheeler.

Mr. Knapp also reported that there is siding falling off of the SRE building at the Airport. It will need to be nailed back on.

Internal Management & Insurance: Mrs. Grier had nothing to report.

Recreation, Website & Chamber: Mrs. Wilt had nothing to report.

Airport: Mr. Wilt reported that he will have to advertise for a RFP for an engineering firm in order to receive grant funding from the FAA for projects at the Piseco Airport. When the proposals come in Mr. Wilt and Mrs. Rudes will go over them to make sure they meet the requirements and then the board can hire who they wish. The next step the FAA has to come back and confirm that the jobs on the capital improvement plan actually need to be done. He said they are six months back logged right now.

Highway Superintendent report: Mr. Small had nothing to report.

Mrs. Rudes said that the board members need to be careful of the email they send back and forth. She feels that they should be as minimal as possible. She also said that she feels the Town Clerk should be CC'd on all of them so there is context on issues if the Clerk needs it. She also said that she feels if they do substantive email correspondence that they be appended to the Town Clerk board minutes. After discussion the board decided to copy the Town Clerk and minimize the amount of email correspondence.

Mrs. Rudes asked if he had given any dirt to private property owners yet. Mr. Small said no and he has gotten six people who have filled out release forms, but no dirt has been taken to any of them. She also asked if the highway committee has met and Mrs. Grier said not yet.

Mr. Wilt closed the public hearing on the 2019 Town budget. He said that the budget stayed the same amount as last year and there should be a slight drop in tax bills because the value in the town went up.
