## **Committee Reports:**

Snowmobile Trails & Town Buildings & Grounds: Mr. Knapp reported he received good reports on some of the trails. He also reported there has been a washout down behind Piseco Lake Lodge on the short bridge so they closed the trail. People have driven around the signs and they took the ribbon down. He said they have a plan to put a temporary mat across it for now. Mr. Wilt reported the Town has hired four people to help drag the trails so the trails will get better. Mr. Knapp said they had to put two quarts of transmission oil in the BR groomer and they can't find any leaks. They also replaced the windshield and heater. Mr. Wilt said the bills will reflect they put about \$2000.00 in the BR this month. He said it's a 1997 and it's time to start looking for a new one soon. He will start looking and will bring back pricing to the next month's meeting. Mrs. Wilt will also look for possible grants for a new machine.

Recreation, Website & Chamber: Mrs. Wilt had nothing to report.

Internal Management / Insurance: Mrs. Grier had nothing to report.

**Airport: Mr. Wilt** reported he sent in the pre-application for the lighting at the airport, but it doesn't look like it got in on time due to the government shut down. He feels it will be a project for next year.

Lake, Dam & Invasive: Mrs. Rudes reported Mr. Wilt has been persistent to try to get an agreement from Schnabel to give a proposal for specifications on the new fence that is needed at the Piseco Lake Dam. He said he will be getting a little stronger tomorrow. Mrs. Rudes also reported it is still up in the air of who is going to run the boat wash station at the Popular Point Campsite. The person who the original talks were with has retired and now it sounds like the State wants to purchase another boat wash station to put there. That is not good as we already have one to use there. She also feels the board needs to follow up on the Town running the day use area. Mr. Wilt feels that it can be worked out with the boat wash station issue.

## **New Business:**

**Mr. Knapp** informed the board that he will not be running for the office of Councilman this year. He will be off the board at the end of the year.

**Mr. Wilt** reported to the board that if the Town is going to continue sanding driveways the highway needs more equipment because it can't be done in a timely manner with what they have now2. . Mr. Small suggested purchasing a stainless steel sander for one of the pickups. It will cost about \$5400.00.
