**WHEREAS:** the Arietta Town Board has a current Town of Arietta Employee Agreement Plan in place with a Step and Grade System, and

**WHEREAS:** the Step and Grade System does not allow for anyone who has reached the final step an incentive for additional training, licensing, and certifications to enhance his/her position beyond their regular duties that enhances the Town of Arietta, and

**WHEREAS:** the Highway Department Employees are given annual winter call-in-bonuses as an incentive over their Step and Grade or can move up to a different scale on the step and grade, and

**WHEREAS:** the General Department does not have any incentives for employees who have reached the final step in the Step and Grade Wage Scale who continue to enhance their duties for the Town of Arietta or move to another Scale, and

**WHEREAS:** after review of the current Town of Arietta Employee Agreement Plan the Arietta Town Board will allow the following incentive for the General employees who have reached the final step on the wage scale and have taken additional training and become certified beyond their regular duties and continue to stay certified an annual amount of \$750.00 or a \$1.00 hourly raise above the regular wage scale, and

**WHEREAS:** this will be given at the time of the initial certification and thereafter annually on the last payroll in December or in the hourly wage each payroll to employees who keep the certifications current, and

**THEREFORE, LET IT BE RESOLVED:** the Town Board, Town of Arietta authorizes the incentive for the General Employees for additional training, license, and certification to enhance his/her position beyond their regular duties as outline above.

Airport: Supervisor Wilt said he has had a lot of contact with the FAA and the Engineering firm over trying to get the 2015 lighting grant extended into 2016 year. Looks like they may do that. Wilt said he has to go to NYC for a meeting on January 25<sup>th</sup> 2016 about the through the fence plan which is a complication, the FAA seems to want to extend the grant and ad more money to it. Since it was part there fault, we went out to bid for something that did not exist. When the bids came back a bidder said he would do it but someone would have to pay for the certification of the lights. No one has certification for those lights. The FAA and Engineers have played fault in it so the FAA will fund rebidding and engineering. The lights we have now are not certified. All of this means we will have to amend the master plan in 2008 or 2009 it will take 6 to 9 months.
