

# Minutes of the Special Town Board Meeting of the Town of Arietta held January 19<sup>th</sup>, 2017 at the Piseco Community Hall, commencing at 6:00pm.

Supervisor Wilt opened the meeting at 6:00pm.

**Supervisor Wilt** opened the meeting at 6:00am.

**Mr. Wilt** went over the audits received from the Town's independent auditor Richard Dinolfo for the years of 2014 and 2015. He said that he hasn't gone over the numbers with Joyce Page yet, but he thinks that some of the numbers are wrong. He will go over the numbers and then talk to Mr. Dinolfo.

**Mrs. Rudes** requested as soon as Mr. Wilt receives correspondence addressed to the Town Board that he forward them on to the rest of the board. He said he would do that. He said that he just got them today and it was mailed on January 29, 2016.

**Mrs. Rudes** commended Joyce Page and Marion Parslow for how well they keep the books for the Town.

Mr. Wilt informed the board that the Lake committee will be dealing with DEC about closing Popular Point Campsite and the Town getting permission to run the boat launch to keep it monitored for aquatic evasive species.

**Mr. Wilt** reported he contacted the engineers for the community hall roof project and he will set up a conference call

**Mr. Wilt** reported that he would like to close out the lighting project from three years ago because it isn't going to be done now. He said the Town will still have to pay the engineering costs. The Town can pass the money on to another airport of our choice for them to use.

**Mrs. Rudes** asked about how long the mapping of the cemetery plots has been in progress. Mr. Wilt said that Lenny Croute is doing it on his spare time, but it has been five years. He said Mr. Croute is doing a good job and he should be done sometime this summer. Mrs. Rudes also suggested that someone puts all new burials on a map with numbers.

**Mr. Wilt** reported that the Town's gaming requirements are in place now.

He sent a letter back to the Unified Court System and asked them how the Town can build a court room to their specifications for \$13,000.00. He said that much of the work will need to be done in house with Town employees to save costs. He will talk to engineers when they have conference call and see how far the \$13,000.00 will go. Mrs. Rudes asked for a copy of the letter.
