# Subject: Medical Insurance Premium and Removal of Availability of Medical Insurance for "Ineligible" Employees and Elected Officials

Resolution Offered By: Jacqui Grier

**WHEREAS:** the Town of Arietta Town Board, after consideration, would like to update the current employees' medical insurance premium coverage costs and to clarify the Town's position on offering medical insurance to ineligible employees by removing the Availability of Medical Insurance for "Ineligible" Employees and Elected Officials paragraph under section 806 of the Town of Arietta Employee Handbook, and

**WHEREAS:** the Town Board has decided that it would be beneficial and add incentive to the Town of Arietta employees to change the employees' medical insurance premium coverage costs, and

**WHEREAS:** The Town will pay the full premium for individual, two-person, or family medical insurance coverage, as the case may be, for each eligible full-time employee who was hired prior to October 3, 2011. The Town will pay 90% of the premium for individual, two-person, or family medical insurance coverage for those employees hired after October 3, 2011. The remaining 10% of the premium cost will be deducted from the employee's paycheck, and

**WHEREAS: The** Town will pay the full premium for individual or family medical insurance coverage, as the case may be, for each eligible Town Supervisor or Highway Superintendent whose first term of office commenced prior to October 3, 2011. The Town will pay 90% of the premium for individual, two-person, or family medical insurance coverage for a Town Supervisor or Highway Superintendent whose first term of office commenced on or after October 3, 2011. The remaining 10% of the premium cost will be deducted from the Elected Official's paycheck, and

**FURTHER WHEREAS:** the Town would like to clarify the Town's position on offering medical insurance to ineligible employees by removing the following paragraph from the Town of Arietta Employee Handbook under section 806 Medical Insurance, paragraph titled "Availability of Medical Insurance for "Ineligible" Employees and Elected Officials"- An employee or Elected Official who is not specified above as "Eligible" may participate in the Medical Insurance plan offered by the Town, provided that the employee or Elected Official must pay the full cost of the monthly premium. Payment must be received on a timely basis, or the Town reserves the right to cancel coverage as it sees fit.

**WHEREAS:** it is also necessary to change the Town of Arietta Employee Handbook to reflect these changes, as outlined in the attachments hereto, and

**THEREFORE, LET IT BE RESOLVED:** the Town of Arietta Town Board will accept the changes as outlined above and attached hereto does approve the stated changes to the Arietta Employee Handbook and will make said policy changes effective January 1, 2025.

# **COMMITTEE REPORTS:**

<u>**Town Buildings and Grounds**</u> Doug Stobo reported that had heard from Kailie Snyder from Adirondack Extreme Cleaning regarding the Spring Cleaning of the Community Hall. She had a bid of \$250.00. Discussion followed, and the

Supervisor asked for a motion to accept this bid. The amount does not exceed \$250.00. Jacqui Grier offered the motion and Johnny Rajca seconded. All the members in attendance were in favor. Motion passed.

**<u>Recreation/Website/Campsite</u>**- Christy Wilt reported that the Halloween Boo Bus will be bringing the children around for Trick or Treat on Saturday 10/26/24.

<u>Lake/Dam/Cemetery</u>- Johnny Rajca reported the owner of the property across from the Oxbow Inn still has trees on wires. He needs to contact National Grid for assistance.

<u>Finance/Internal Management/Airport/Insurance</u>- Chris Rhodes stated that the grant for the Skid Steer for the airport has been approved. He reported there are grants available and wanted to know what the board thought about applying for these grants.

One would be used for a large finish mower for the airport, and the other for an extension to the existing hanger. Doug Stobo made a motion for the Supervisor to go ahead and apply for these grants. Johnny Rajca seconded the motion. All members were in favor. Motion passed.
