COMMITTEE REPORTS

Snowmobile Trails-Jacqui Grier- was absent from meeting.

Town Buildings and Grounds- Doug Stobo-nothing new to report.

Recreation/Website/Campsite- Christy Wilt reported that Sheila Crouse is having YOGA tonight from 7-8 pm here at the school. If there is enough interest, she would be willing to continue to have the class. This Friday the 25th will be the last Bingo for the summer.

Lake/Dam/Cemetery- Chris Rhodes reported that the lake level was down 51/2 inches this morning.

Finance/Internal Management/Airport/Insurance- Chris approached the subject of the fuel pump card reader on the airport. At this time, it is working, he feels that it is undependable, and the board should think about a possible replacement in the future. The board will talk more about this at budget time. There was a generator in the Airport Improvement Plan, but it was extremely expensive and was removed. This also will be revisited at budget time.

Superintendent of Highways- Craig Small reported that the East Shore Rd was “ground up” today but he is unsure of when the paving will take place as the paver is being used elsewhere.

Codes and Zoning- Mel Lascola shared with the board that at the last Planning Board Meeting, a resident was talking about information that he found on the Website regarding signs. The information was not up to date. Christy Wilt will check on the website to see what if anything needs to be done. Chris explained he has had complaints on several properties in the town. A discussion followed regarding the next step with addressing these complaints. Mel will follow up with this and send letters to owners of these properties.

Old Business-none to be discussed.

New Business: The new business discussed was the town going from .com domain to .gov domain. Vector One stated it would take approximately 6-8 hours to do this. After discussion he asked for a motion to have Vector One proceed with the changeover. The motion was offered by Doug Stobo and seconded by Christy Wilt. All members were in favor. Motion carried. After this is completed, a new website can be designed.

Supervisor asked for a motion to accept the bills as presented. Doug Stobo made a motion and Christy Wilt seconded. All members were in favor. Motion carried.

PUBLIC COMMENT:

Judy Ford brought to the board a request from a resident that would like to have the stream area around her home retreated as the black flies are back in force. Chris explained that it had been treated and when the stream was rechecked there was no eggs. He will contact the technician and have the stream rechecked.

Marie Buanno stated that a resident that came to the Planning Board Meeting stated he found the Arietta Website difficult to navigate. Christy Wilt explained that she had not made any changes, and the site cannot be reformatted until the town has a .gov domain.

Marie also had a complaint regarding a trailer on the property next to hers that has fallen in and has been uninhabited for many years. There was a discussion regarding who owns the property and how to contact this person. She would like her name added to the list of complainants regarding properties in the tow, (see Codes and Zoning).
