**WHEREAS:** the Town of Arietta's existing Salary Structure does not contain the title BTI Pesticide Applicator (P/T), and

**WHEREAS:** It is optimal to add BTI Pesticide Applicator (P/T) to the Town's Salary Structure to accommodate the new classification for said employees, and
