Committee reports:

Airport: Mr. Wilt reported that he thought about the lighting repair it might be a good time to remove the helipad. What he found out is that it might be harder to remove it than keeping it due to regulations needed to be met with the removal procedures. The fuel construction contract is going to be set back until May instead of April.

Street Lights: Mrs. Grier reported she knows which lights are out she just needs to get the pole numbers and report them.

Insurances: Mr. Baker had nothing to report.

Snowmobiles: Mr. Knapp reported that they are all put away.

Youth: Mrs. C. Wilt reported that the Piseco School has a budget of \$4500 for the ski program and the Town board will have to pick up the rest of the charge which is \$835.00.

Town Clerk: Mr. K. Parslow reported he filed monthly reports with the State, County and the Supervisor.

Highway: Mr. W. Parslow told the board that the annual agreement needs to be signed by the board to spend funds on Town highways before he starts work.

Old Business: Mr. Wilt reported that the Town needs to get out a recycling letter to the taxpayers of Arietta. It is necessary for the Town to let people know what is and what isn't recyclable. He will try to get it ready to go out with the annual letter going out on May 6th. The board discussed large trash pickup and decided to have large pickup on the first Thursday in June and the first Thursday in August 2014. Mr. Wilt read a letter from the Piseco Lake Association asking for the Town to reinstate a brush removal program. Mr. Wilt said that it would have to be monitored by an employee and only individuals would be able to bring in brush. No contractors will be allowed to bring brush in and it can't be over 3" at its largest diameter. Contractors will have to take care of any brush they have by themselves. Mr. Wilt said that it will have to be chipped by the Town highway employees as they get time. The board will look for a place to do it. Mr. Wilt will put this in the recycling letter as well.

Mr. Wilt told Mr. W. Parslow that he will send out agreements with the school, fire department and ambulance to sign for winter snow removal on their properties.

She asked if there was money enough for that. Mr. Wilt said that if that was considered than he feels the position should be advertised in the paper. He also said he would look at the budget figures for insurance to see if there is adequate funding.
